### SB35/HB135 **CRIMINAL LAW: Offense of reckless endangerment by discharging a firearm into a parade or religious service.**

**Summary:** Creates a Class C felony offense of reckless endangerment when someone discharges a firearm into a parade, religious service, concert, athletic event, political event, educational event, or into any other group of 25 or more people who are lawfully assembled.

**Amendment Summary:** Senate Judiciary Committee amendment 1, House Judiciary Committee amendment 1 (004918) declares exemption to the crime of reckless endangerment by discharging a firearm if done by a member of a law enforcement agency or any branch of the military acting in the course of a person's official duties, involves the firing of non-live ammunition as part of a funeral, or occurs in a location where participants have assumed the risk of the activity involving the discharge of a firearm, including group hunting activities.

**SB1010/HB1427 CRIMINAL LAW: Sale or transfer of certain firearms completed through licensed gun dealer.**

Summary:

Requires all firearm sales or transfers in this state including to be subject to a criminal history record check unless specifically exempted by state or federal law. Specifies that the criminal history record check requirement applies to all sales or transfers made by a licensed gun dealer as well as sales and transfers at a gun show, online, or between persons who are not licensed gun dealers. Requires, when neither the seller nor purchaser of a firearm is a licensed gun dealer that the transaction be completed through a licensed gun dealer, and that the dealer perform the background check. Requires the licensed gun dealer, if the results of the criminal history record check indicate that the purchaser or transferee is ineligible to possess a firearm, to return the firearm to the seller or transferor. Allows the licensed gun dealer to charge a fee that reflects the fair market value of the administrative costs and efforts incurred by the licensed gun dealer for facilitating the sale or transfer of the firearm.

Summary: Allows any family member, household member, intimate partner, or law enforcement officer who reasonably believes a person is at risk of harming others if in possession of a firearm to file an emergency order of protection against that person. Upon filing the petition, the courts can immediately issue an ex parte emergency protection order, which will prohibit the person from purchasing or owning a firearm during the time of the protective order. Requires a hearing to be held within 30 days of order's issuance at which time the court may dissolve or extend the protective order for up to one year. Creates a Class A misdemeanor for a violation of an emergency order of protection. Establishes other requirements for an emergency protection order. Broadly captioned.

**SB1985/HB2027 CRIMINAL LAW: Extends validity of enhanced handgun permits.**

**Summary:** Extends the validity of enhanced handgun carry permits issued on or after January 1, 2021 for the duration of the permit holder's life. Requires the department of safety to run a name based criminal history check every five years to determine if the permit holder continues to meet requirements and if not, the department must revoke or suspend the permit. Creates other requirements regarding the suspension of a permit.

**Amendment Summary:** House Judiciary Committee amendment 1 (014980) deletes and replaces all language after the enacting clause. Increases the number of name-based criminal history background checks run on handgun permit holders from every five years to every four years. Broadens the ability of a permit holder to prove a delivered renewal permit application by deleting the requirement that the permit holder provide a receipt of the renewal application fee.


