EDUCATION: Allows schools to post firearm safety curriculum online. Allows an LEA or school that offers a firearm safety class or program to elementary school students to post the curriculum and educational materials on the school's or LEA's website.

Amendment Summary: House Education Curriculum, Testing & Innovation Subcommittee amendment 1 (016583) requires the department of education in conjunction with the TWRA determine the earliest grade in which it is appropriate for students to receive gun safety instruction. Requires the departments to study all relevant data and risk factors in their determination. Requires LEAs and public charter schools, starting with the 2021-2022 school year, to provide annual age and grade appropriate gun safety instruction that begins at the earliest appropriate grade as determined by the departments. Establishes requirements for the education including how to avoid injury, to never a found firearm, to immediately notify an adult of the location of a found firearm, to not include live ammunition or firearms, and to be provided within one 15 minute period. Requires the department of education and TWRA to develop and approve the curriculum.

12. **SB2671** Johnson

CRIMINAL LAW: Reporting issuing and denying judges' decisions. Increases amount of time an issuing or denying judge is required to report to the attorney general and reporter the denial or an order approving an interception from 30 to 45 days after the expiration or extension of the order. Broadly captioned.

Governor's permitless carry defense bill.

Amendment Summary: Senate Judiciary Committee amendment 1, House Constitutional Protections & Sentencing Subcommittee amendment 1 (015802) creates exceptions for the offense of open or concealed carrying of a firearm with the intent to go armed for any person legally in possession and not prohibited from carrying a firearm. Specifies that theft of a firearm worth less than \$2,500 is a Class E felony offense. Enhances the mandatory confinement period for theft of a firearm to 180 days. Creates an enhancement factor when an offense involved the theft of a firearm from a motor vehicle. Requires no release eligibility for certain offenses committed after July 1, 2020 unless 85 percent of an imposed sentence is served, less sentence credits. Prohibits a reduction of such sentences less than 70 percent of the sentence imposed.

Comment: This is the "Governor's" bill which is mischaraterized as "constitutional carry". It IS NOT constitutional carry. This bill creates an exception for only those individuals who would be eligible to be issued an enhanced handgun permit (but who have not done so) to carry in very limited locations without a permit. Further, it provides no option to carry in public parks or public buildings. It will not protect an individual from being fired if they store a handgun in their personal car at work (a permit will prevent that). The bill appears PRIMARILY designed to increase penalties on some criminals and to increases state expenses to do so.

10. **SB2556** Jackson

CRIMINAL LAW: Allows law enforcement officers to carry handguns in posted areas. Allows law enforcement officers to carry handguns in posted areas under certain circumstances even when the owner or entity prohibits and restricts the possession of weapons. Broadly captioned.

<u>Amendment Summary:</u> House Judiciary Committee amendment 1 (013800) deletes and replaces all language after the enacting clause. Clarifies that law enforcement officers are exempt from laws allowing individuals, corporations, businesses entities, or local, state, or federal government entities or agents to prohibit firearms on property they own, operate, or manage.
