Requires, when neither the seller nor purchaser of a firearm is a licensed gun dealer that the transaction be completed through a licensed oun dealer, and that the dealer perform the background check, Requires the licensed oun dealer, if the results of the criminal history record check indicate that the purchaser or transferee is ineligible to possess a firearm, to return the firearm to the seller or transferor. Allows the licensed oun dealer to charge a fee that reflects the fair market value of the administrative costs and efforts incurred by the licensed gun dealer for facilitating the sale or transfer of the firearm.
