Prohibits the state and all political subdivisions from using public
 - resources to enforce, administer or cooperate with the enforcement of any such regulation. HB902 CRIMINAL LAW: Department of safety annual report on handgun carry permits provided electronically. Authorizes the department of safety to provide its annual report on handgun carry permits to the members of the general assembly electronically. Broadly captioned.

<u>Amendment Summary:</u> House Civil Justice Subcommittee amendment 1 (004577) deletes all original language in the bill and retitles the bill the "Second Amendment Privacy and Protection Act of 2021." Prohibits state and local government entities from making or maintaining any record or database regarding the ownership or possession of a firearm, ammunition or firearm accessory. Establishes that violation of this is a class E felony. Establishes exemptions for records required to be maintained by a licensed dealer, a registry of stolen firearms and records regarding evidence.

 SB404 PROFESSIONS & LICENSURE: Retired law enforcement officers - private protective services. Permits a retired law enforcement officer who is authorized to carry a firearm in the same Haile F. manner as an active law enforcement officer to provide private security services without completing the required firearms training. Broadly captioned.

<u>Amendment Summary:</u> House Civil Justice Committee amendment 1 (004868) allows retired LEOs to have more options in meeting requirements to gain certification to carry a firearm when working as private security.

3. SB675 CRIMINAL LAW: Fees for expunction. Allows a clerk to charge a fee of less than \$100 for expunction. Expands the offenses for which expunction is permitted

Haile F. <u>Amendment Summary:</u> House Criminal Justice Committee amendment 1 (004783) adds those convicted of the use of a counterfeit mark or logo or money laundering offense to those eligible for an expunction. Specifies that those convicted of offenses involving controlled substances and commercial vehicles or driver licenses are not eligible for expunction. Makes other non-substantial changes to the legislation.

15. HB1321 CRIMINAL LAW: Reckless endangerment definition and punishment. Specifies that the offense of reckless endangerment applies to actions committed by multiple people as well as individuals. Establishes that motor vehicles are deadly weapons for the purpose of reckless endangerment. Specifies that reckless endangerment in a group of two or more people, from within

a motor vehicle or into a motor vehicle is a class C felony that is punishable by the revocation of the person's driver's license for five years. Allows the court to sentence someone guilty of reckless endangerment with a deadly weapon to anger management classes. Establishes a sentence enhancement for acts of reckless endangerment to be acts of community terrorism.
