
Travel/Lodging Information

If traveling straight into Nashville the morning of TFA's annual lobby day, use "425 Rep John Lewis Way N. Nashville 37243" *Parking information is provided in the next section.

If you are traveling to Nashville the day before or prior to Wednesday the 15th, there are a number of hotels in the area. Depending on whether you wish to stay in downtown Nashville or within 10 minutes away from Cordell Hull Building, the below information is one of the newer hotels and easily accessible from I-65/40.

Exit at Rosa L. Parks Blvd for: Holiday Inn Express 301 Clay Street Nashville, TN 37208 To check availability you can contact via phone: (615) 254-6955

From this hotel, Uber or Lyft can be used to transport you to Cordell Hull. Or, Yellow Cab can be reached at: (615) 256-0101 and a typical fair is around \$15.




Parking Information

Parking for the day runs about \$25 in the nearby Premier Parking MTA Garage at 505 Deaderick Street, Nashville 37219.

Note: Parking is a short walk, prepare for March weather – cold wind, hot sun, rain/snow/etc

Payment is by credit/debit card, or you can set up temporary account to pay at: https://premierparking.parkmobile.io/venue/tennessee-performing-arts-center/events



Entering Cordell Hull Building

When you arrive at the entrance of Cordell Hull on Rep John Lewis Way N, at the "Mountain Group Statue" enter the double doors at the top of the steps.



There is a **handicap entrance** to the right of these doors when facing the building if you or someone in your party cannot use the stairs.



Security Check Point

Upon entering Cordell Hull building you will be required to go through the Capitol Security

Check-point.

IF YOU ARE CARRYING CONCEALED YOU MUST PROVIDE YOUR **ENHANCED CARRY PERMIT FOR VERIFICATION!!!**

Permitless carry is not permitted within Cordell Hull. Please do NOT attempt to enter security

without a valid Enhanced Carry Handgun Permit.

Take your permit to the podium at the front corner of the security entrance, TSP will take the

permit and run it through the system to verify it is active and in good standing. HAVING YOUR

PERMIT EASILY ACCESSIBLE AVOIDS DELAYS!

Please note: You do NOT have to show your firearm at any time! They will ask where on your

body you are carrying as you move through the metal detector, POINT in that direction so they

are aware. All other metal items will need to be emptied from your pockets and placed in a bin

to be scanned on the conveyor.

AT NO TIME SHOULD YOU REMOVE YOUR FIREARM!

Office Visits

After check-in, we will divide into groups to visit legislators in their offices. We do NOT have scheduled appointments and will be visiting legislators unannounced.

Committee Meetings

In addition to visiting legislators in their offices, there are several committee meetings that we will plan to attend. The Wednesday committee schedule is as follows:

- Senate Government Ops Committee 8:30am
- House Criminal Subcommittee 9:00am
- House Judiciary Committee 12:00pm
- House Civil Justice Committee 1:30pm

Attendee Meeting and Reception 2:00pm

We will meet in the large conference room on the 8th floor where legislators and TFA and GOA leadership will address attendees. Discussions will be focused on how to make sure that Tennessee law complies with the Supreme Court's Bruen decision.

Light refreshments will be provided.

Food Options During Lobby Day

This year participants will be on their own for lunch, with light refreshments provided at the 2pm attendee reception. There is a cafeteria in the Cordell Hull Building and there are also several lounge areas to eat if you pack a lunch.
